


### **Testing Organization Location Map**







## NATE QUICK REFERENCE GUIDE



### Activate myNATE

Use the activation code sent via email upon testing. **myNATE** allows you to easily review continuing education credit balances and expiration dates, upload proof of training and keep contact information up-to-date. Call or email customer service for assistance.

### 2 Earn Training Hours

NATE accepts any training taken in class or online. Courses must be related to a technician's specialty or in general areas such as safety, electricity, controls, codes, and regulations. Find a NATE-Recognized Training Provider at **natex.org** or through the training tab of **myNATE**.

### **3** Track Training

Keep a record of all training courses taken. NATE accepts certifications, rosters, receipts and emails from training providers. The technician's name, NATE ID#, course name, date, and duration are required. NATE-approved courses are automatically uploaded to **myNATE**. Record of any other courses must be submitted to **myNATE**. For assistance, email recertify@natex.org.

### 4 Recertify

When 16 training hours have been approved, eligible technicians may pay renewal fees by phone or online through the NATE store. While NATE accepts payments that are emailed, faxed and mailed, online transactions are secure and much faster!

## RECERTIFICATION

## CEH REQUIREMENTS

- Requires **16** hours of continuing education courses related to the specialty or in safety, electricity, controls, codes and regulations - every years
- NATE accepts training to maintain state licenses, electrical license classes, or OSHA safety training
- Must be **technical** in nature (not sales/human resources)
- NATE gives hour for hour credit, e.g. a 4 hour course awards 4 CEHs
- Courses **DO NOT need to be NATE-recognized**, however:
  - NATE-recognized courses are pre-approved and will automatically be added to accounts when the training organization submits the rosters to NATE. There are **no delays** in NATE reviewing the course
  - Non-recognized courses must be submitted to NATE for review and approval




## **RECERTIFICATION BASICS**

- Two ways to recertify: CEHs or re-taking specialty exam
- CEH: Costs **\$25** for the first specialty, and then **\$5** for each additional specialty
- Exam: The cost for renewal is dependent on the exam provider; there is not a unique exam for recertification
- Like your initial certifications, service specialties award their installation counterparts for free, and Air to Air Heat Pump awards its AC counterparts for free
- For example, to renew HPSV, HPIN, ACSV, and ACIN you would either only pay \$25 with CEHs, or just take the HPSV exam

- Any NATE-recognized courses a technician takes should be automatically tracked after their instructor uploads a course roster
- However, a technician can submit proof of training for any non-NATE recognized course they take on their myNATE profile. Technicians can also submit proof of training for NATE recognized courses if they haven't been tracked
- Examples of non-NATE recognized courses would be things like training to maintain a state license, electrical license classes, or OSHA safety training



## EXPIRATION


- Once a technician's certification expires, there is a 120 day grace period
- If the technician does not recertify in their 120 day grace period, they would need to re-take both the Core and a specialty exam.

## ONLINE RECERTIFICATION







- Need to re-take the specialty exam you were previously certified in to renew it
- You do not need to re-take the Core if you are testing before your certification expiration date or during the grace period
- Contact a local testing organization to schedule a testing session. Same process as the initial certification
